C. Complaints Requiring Board Guidance:

1. P21-046, Julius Doan, Non-Registrant

Respondent appeared telephonically.

This investigation alleges that Respondent, an unlicensed engineer, affixed a seal belonging to an Arizona PE to plans he submitted to eth city of Prescott Valley.

Respondent stated that he went through a third party, Upwork, to contract himself out for engineer work; that Mr. Alphonso hired him to complete the project in this matter; that investigator Correll requested documentation regarding his relationship with Upwork; and, that he had been unsuccessful in obtaining said documentation from Upwork.

Investigator Correll stated that she did not believe Mr. Alphonso forged Mr. Porter's seal; that Respondent refunded Mr. Alphonso's money; that Respondent asked questions about the consequences of a violation of this sort; and that Respondent has been unable to prove that a third party worked on the project in this matter, leading her to opine that Respondent forged Mr. Porter's seal. Respondent responded that the city rejected Respondent's submitted plans and so Mr. Alphonso requested his money back, which he quickly refunded.

Mr. Gilmore asked where someone obtained Mr. Porter's seal. Investigator Correll answered that she did not know, but she stated that it was blatantly a forgery and that she was unsuccessful in contacting anyone at Upwork. Mr. Jones asked if Staff informed Mr. Porter of this matter. Investigator Correll answered 'yes' and she stated that Mr. Porter indicated that he had nothing to do with this project.

Dr. Angel asked why Respondent was unable to log into Upwork and submit the documentation the Board requested. Respondent stated that Upwork no longer recognized his account. Investigator Correll opined that Upwork suspended Respondent's account. Dr. Angel asked if the Board could subpoena Upwork. Investigator Correll said she could try; however, Upwork could just ignore the Board's subpoena because they were incorporated in California.

Ms. Wycoff asked how Upwork conducted business. Respondent answered that it was a service connecting professionals and clients, that he was registered as a PE in Texas, that he would offer his services through the platform, complete plans and then have a local professional seal the plans for a nominal fee. Dr. Angel opined that Registrant's payment to a professional who was not head of the project was a possible violation of the Board's Practice act.

Dr. Angel moved and Mr. Jones seconded to direct staff to subpoena Upwork for communications and documentation related to Respondent; motion carried unanimously. The Board directed investigative staff to research Upwork, its practices and how it provides its services.

Board staff attempted to contact Respondent telephonically, twice, without success. Assessor, Mr. Marmon P.E., appeared telephonically.

Ms. Wyckoff indicated that she knew Respondent but could be fair and impartial.

Mr. Marmon stated that, after reviewing and assessing this matter, he believed Respondent's technical skills were adequate, but her project management skills were lacking.

Dr. Angel agreed with Mr. Marmon, stating that Respondent's actions rise to gross negligence. Mr. Gilmore asked staff if Respondent communicated what was delaying her projects. Investigator Thacker stated that his discussions with Respondent revealed that she was a well known and sought after engineer and she was therefore very busy; that the Board had received many calls regarding Respondent's lack of follow through; that the alleger for this matter contacted him yesterday stating they wished to drop the case since Respondent was now moving the project along; Investigator Thacker indicated that this was not the first time an alleger asked the Board to drop a case against Respondent; and, that Respondent was not timely with answering staff's requests, or didn't respond at all.

Dr. Angel stated that he would make a motion to offer a consent agreement to Respondent for gross negligence or incompetence in the practice of the profession because of the expensive timelines for Respondent's clients, her inability to respond to Board requests, and for the repeated complaints that the Board had received regarding her practice.

Dr. Angel moved and Mr. Jones seconded to offer Respondent a consent agreement comprised of the following: the Board shall issue a Letter of Reprimand to Respondent, Respondent shall pay a \$150 administrative penalty and the Cost of Investigation, Respondent's license shall be placed under Stayed Suspension and Probation, and Respondent shall complete remedial education in the form of an ethics course, and, if not signed within 30 days, move to formal hearing; motion carried unanimously.

Mr. Gilmore opined lifting the stay knowing that Respondent could later comply with the Order.

Dr. Angel moved and Mr. Jones seconded to lift the stay of suspension for lack of compliance with a Board Order; motion carried unanimously.
