3. ADOPTION OF MINUTES

Review, Consideration, and Possible Action on the following:

Mr. Gilmore moved and Mr. Jones seconded to approve the minutes; motion carried. Mr. McAllister abstained.

4. CONSIDERATION OF CASES REFERRED FOR FORMAL HEARING

The Board may vote to enter executive session pursuant to A.R.S. § 38-431.03(A)(2) (to discuss confidential information), A.R.S. § 38-431.03(A)(3) (to receive legal advice) on agenda item 4(A).

A. Formal Hearing

1. P18-070, P19-031 & P21-045, Takach, Peter, Engineer (Civil) #44085

Scott Donald, A.A.G., appeared before the Board representing the State. Sunita Krishna, A.A.G., appeared before the Board as independent advisor to the Board. Respondent appeared before the Board with counsel, Julianne Wheeler.

Mr. Donald stated that both parties stipulated Exhibits 1-7.

Mr. Donald stated in his opening statement that Respondent violated the Board's Practice Act when he practiced structural engineering after signing a consent agreement restricting his practice of structural engineering and that he recommended the Board adopt the factual allegations in the complaint as the Board's Findings of Fact, the alleged violations as Conclusions of Law and that the Board lift the stay of revocation on Respondent's license and require him to pay the Board's investigation costs and attorney fees.

Ms. Wheeler stated in her opening statement that Respondent did not deny violating the July 2020 Board Order but asked that the Board not revoke Respondent's license.

Mr. Donald called his first witness, Board investigator Erin Correll, and Ms. Wyckoff swore her in. Mr. Donald questioned Ms. Correll. The Board admitted exhibits 1-7, and later, after objection from Ms. Wheeler, exhibit 8. Ms. Wheeler cross-examined Ms. Correll. Mr. Donald did not redirect questions to Ms. Correll.

Mr. Noel asked for clarification regarding the branches of engineering and the Board's exceptions to practice outside of one's branch. Ms. Correll obliged.

Mr. Donald called his second witness, structural engineer and EAC member Melvin Slaysman, structural engineer license #11110, and Ms. Wyckoff swore him in. Mr. Donald questioned Mr. Slaysman. Mr. Wheeler cross-examined Ms. Slaysman. Mr. Donald redirected questions to Mr. Slaysman.

Board members asked questions of the witness, after which the State rested.

The Board took a break at 11:09am and returned at 11:21am.

Ms. Wheeler called her only witness, Respondent Peter Takach, and Ms. Wyckoff swore him in. Ms. Wheeler questioned Respondent. Mr. Donald cross-examined Respondent. Ms. Wheeler did not redirect questions to Respondent.

Board members asked questions, and both counsel for the Respondent and counsel for the State asked follow-up questions. Counsel for Respondent objected to a line of questioning posed by the State, but was overruled.

Respondent rested.

The Board took a break at 12:55pm and returned at 1:07pm.

Mr. Donald reiterated in his closing argument that the Board should lift Respondent's stay of revocation and require him to pay costs and fees.

Ms. Wheeler stated in her closing argument that there were alternatives the Board could consider in its Order other than revocation of Respondent's license.

Mr. Donald stated in his rebuttal that the EAC categorized Respondent's alleged violations as highly egregious in nature and that Respondent lacked the technical knowledge and skill to perform structural engineering work.

The Board engaged in discussion, after which Mr. Everroad moved and Mr. Noel seconded, based upon the preponderance of the evidence, to adopt factual allegations 4 through 10 in the Complaint as the Board's findings of fact with a rewording to allegation 8b; motion carried. Mr. Hack voted Nay.

Mr. Everroad moved and Mr. Noel seconded to find the findings of fact constitute a violation of the statutes (and/or rules) set forth in paragraphs 11 through 16 of the Complaint; motion carried. Mr. Hack voted Nay.

The Board discussed terms for a potential Order. Mr. Noel moved and Ms. Wyckoff seconded to issue the following Order: lift the stay of revocation and revoke Respondent's civil engineering license #44085; motion carried. Mr. Hack voted Nay.

The Board took a break at 2:33pm returned at 2:40pm.

Mr. Hack opined that the matter be dismissed stating that Respondent learned his lesson and disciplinary action was not required.

Mr. Gilmore moved and Mr. McAllister seconded to accept signed consent agreement; motion carried. Mr. Hack voted Nay.

Mr. Gilmore moved and Mr. McAllister seconded to accept signed consent agreement; motion carried unanimously. D. Complaints Proposed to Offer Consent Agreement:

1. P21-004, Susan Link, R.A. #43079 and Link Architecture, Firm #22993

Investigator Thacker informed the Board that Respondent signed the Consent Agreement and he recommended the Board accept it.

Mr. Jones moved and Mr. McAllister seconded to accept the signed consent agreement; motion carried. Mr. Hack voted Nay.

E. Reconsideration of Prior Board Action to Review, Discuss and take possible Action on Registrant's Request for Modification of Order of Discipline:

Respondent appeared telephonically. A.A.G. Deanie Reh appeared telephonically.

Ms. Reh stated that Respondent requested that the Board remove or reduce his civil penalty because of credit-time served during his incarceration; she opined that the Board did not have the authority to credit time served but the Board did have the authority to reduce the civil penalty or extend the period in which Respondent had to pay the fine.

Respondent requested that the Board either dismiss the case, reduce the penalty or extend the deadline to pay the penalty fee.

Mr. Noel moved and Mr. McAllister seconded to extend the period in which Respondent had to pay his civil penalty six months; motion carried unanimously.
