This matter came before Administrative Law Judges (ALJ) Jenna Clark on March 31, 2020, and Tammy L. Eigenheer, on October 1, 2020, in the Office of Administrative Hearings. On October 20, 2020, ALJ Eigenheer issued a recommended decision to revoke Gerald Clark's (Respondent) registration as an architect, pay the costs and fees incurred by the Board during the investigation and prosecution of this matter, and require Respondent firm to pay a sum of \$2000 as a civil penalty pursuant to A.R.S. § 32-106.02(B).

On October 27, 2020, the Board met and considered whether to accept, reject, or modify the ALJ's Decision pursuant to A.R.S. 41-1092.08(B). Assistant Attorney General Mona Baskin was present to provide the Board with independent legal advice. Respondents did not appear at the meeting and were not represented by an attorney. Assistant Attorney General Scott Donald appeared on behalf of the State.

Having considered the State's argument, the Board voted to accept the ALJ's Findings of Fact and Conclusions of Law, and Issues the following Order:

FINDINGS OF FACT

1. The Board adopts Findings of Fact, paragraphs 1 through 15, of the Administrative Law Judge's Recommended Decision attached hereto and incorporated herein by this reference.

CONCLUSIONS OF LAW

2. The Board adopts Conclusions of Law, paragraphs 1 through 16, of the Administrative Law Judge's Recommended Decision attached hereto and incorporated herein by this reference.

ORDER

Based on the Board's adoption of the Findings of Fact and Conclusions of Law, the Board adopts the ALJ's recommended Order as provided below, attached hereto, and incorporated herein by this reference.

Respondent's Professional Architect Registration No. 32055 issued by the Board is hereby revoked as of the effective date of this order and Respondent shall pay the costs and fees incurred by the Board during the investigation, \$637.00, and prosecution of this matter, \$2,107.

Respondent Firm shall pay the sum of \$2000.00 as a civil penalty pursuant to A.R.S. § 32-106.02(B).

Right to Petition for Rehearing or Review

Respondents are hereby notified that they have the right to file a motion for rehearing or review. Pursuant to A.R.S. § 41-1092.09(B) and A.A.C. R4-30-126(A) the motion for rehearing or review must be filed with the Board's Executive Director within thirty (30) days after service of this Order. Service of this Order is defined as five (5) calendar days after mailing. A.A.C. R4-30-126(A).

The motion for rehearing or review must set forth legally sufficient reasons for granting a rehearing or review. A.A.C. R4-30-126(C). If a petition for rehearing or review is not filed, the Board's Order becomes effective thirty-five (35) days after it is mailed to Respondents. Respondents are further advised that the filing of a motion for rehearing or review is required to preserve any rights of appeal to Superior Court.
